## VISITOR DAY USE MOORAGE POLICY

REV 250601

### Definitions:

Visiting Anchor Outs are boat owners who anchor their vessel offshore, in open water for less than one week. Vessels are to remain outside the boundaries of the navigational channel **as marked and defined by Transport Canada**.

Dinghy Access arrivals by dinghy to visit a marina business or service only.

Dinghy Dock is located on the south side of H dock; the slips located directly behind the fuel dock. This dock is intended for boats/tenders less than 12 feet LOA.

Day Use Moorage Vessels requiring day-use, short term moorage for up to 4 hours. Moorage is available at the discretion of the Visitor Services staff. Vessels will be directed to an appropriate available slip – not necessarily H dock.

**Non-moorage customers are permitted** to use the Dinghy Dock or a slip assigned by Visitor Services **on a complimentary basis for a maximum of 4 hours daily**. Permitted use is to **access marina services including the restaurant, pub, stores, and other on-site businesses**. Access to facilities or amenities such as washrooms, garbage, recycling, potable water, and use of recreational facilities are also welcome and available for a **fee – see price list**.

**THE OWNERS OF ANCHOR OUT VESSELS MAY NOT TRESPASS THROUGH MAPLE BAY MARINA PROPERTY TO ACCESS OFF PREMISE PROPERTY, VEHICLES, AND/OR BUSINESSES.**

### Conditions:

Guests/Vessels arriving by water need to check in with Visitor Services at the Fuel Dock or on VHF 66a. Moorage fees will apply for all stays longer than 4 hours or when overnight moorage is required.

Maple Bay Marina is private property. Property access for non-moorage customers is welcome, provided Maple Bay Marina services and/or businesses are being accessed. Non-related access is strictly prohibited. Alternate public access is readily available at the government dock, located on the northwest side of Maple Bay.

Dinghy access is restricted to the location outlined in the definitions section of this policy. Any vessel, including dinghies located elsewhere on marina property without explicit permission, will be removed without notice.

On site parking (Lot A or B) is available to visitors of Maple Bay Marina services and/or businesses and moorage customers only. Overnight parking is strictly prohibited. Please be advised that unauthorized vehicle parking and vessel access through Maple Bay Marina property will result in fines and/or removal without notice.

Cross-dock fees are in effect and may be arranged in advance by contacting Visitor Services or the Marina Office.
